Development of civil rights and human rights standards are in the prison system: postponement and suspension of punishments, the semi-freedom, the development of conditional release, over time, of repentance and the pardon and exemption from punishment, along the traditional criminal law, that proposed Code of Criminal Procedure of the facilities and legal instruments concerning the enforcement and penalties Prison reform bill has been entered. So that after restoring the separation of the public prosecutor and the prison authorities, the bill has arrived.

Criminal and prison guards to its promise:

Act respecting the legitimate rights and freedoms: their basis in human universal rights cases 1,3,5,6,7,8,9,11, and articles 7,9,14,16 and 17 of the Covenant on Civil and Political Rights and the Treatment of Prisoners, Basic Principles, paragraph 1, found subparagraph 2 Article 11 Standard Minimum Rules for the Administration of Juvenile Justice,. Humanity and human dignity that is unjust or contrary to the duty of all persons and the protection of the law all are equal before the law, is obliged to apply any kind of discrimination and prevent rape. The judiciary should dispute any claim that any person has violated law, hearings and proceedings and the arrest, detention and arbitrary deportation and refused to consider the presumption of innocence. Respect the right to defend against known and adhered to at all stage. The agencies overseeing the police and the chase for the prevention of abuse of power put in your applications.

Hence, this directive is to the legal aspects, in addition to the emphasis on due process of law and human rights, the observance of the legal issues in practice are also emphasized. (1 p., 332)

The prisoner's civil rights laws:

One of the principles of civil rights is that the penalty should not be detained for more than the amount specified in the law to bear. In this regard, Article 39 of the constitution states that "defamation law and the dignity of the person arrested, detained, imprisoned or deported to any of the prohibited and liable to punishment» or put under pressure not as food, water, clothing, medical facilities and the provision of any violence that is incompatible with human dignity and principles.

The constitution in Article 579 of the penal code has been implemented, so that this matter has acknowledged that prisoners should not be punished more than the amount specified in the law, to tolerate.

Enable him to contribute back to society. Otherwise, only the penalty depriving of liberty, not supply, but the devastating effects and consequences for society will be sought and created (1 pp, 233, and 234).

#### **RESULTS**:

As a result, this topic should be said, like other prisoners, and a man should preserve his dignity and rights. After the humiliation and insult and disrespect to him, is explicitly prohibited by the laws and regulations. He also stressed the need to respect the dignity and character.
